

### The Law - Statutory Laws

- Supremacy Clause, U.S. Const., Article VI
  - "<u>This Constitution, and the Laws of the United States</u> which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, <u>shall be the supreme</u> <u>Law of the Land</u>; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any state to the Contrary notwithstanding."


#### **State Laws**


